The progress in data uploading in the State of Telangana as on 16.10.2015 as also available on the AISHE Portal (aishe.gov.in) is given below for your kind perusal:

The closing dates for AISHE 2013-14 and 2014-15 is 31st October, 2015 and 30th November, 2015 respectively. Since we are planning to launch the survey for the year 2015-16 in the month of November, 2015, it would be appropriate to complete the data uploading of the earlier years' survey to avoid confusion by running parallel surveys.

Further, Smt. Ishita Roy, Joint Secretary, Department of Higher Education, Ministry of Human Resource Development categorically mentioned during the video-conferencing that the funding under RUSA to States/UTs is linked to uploading of the data for AISHE by all the institutions, both public and private, located in the States/UTs. She also emphasized that the States may consider getting the data uploaded through a campaign mode to avoid any further delay.

In view of the above, I request you once again to personally look into the matter and get the data uploaded by the remaining institutions in the State at the earliest. We are ready to provide all possible support in this regard.

As you are aware, all the Higher Education Institutions have to upload data on the All India Survey on Higher Education (AISHE) portal (aishe.gov.in). The Ministry of Human Resource Development, Government of India, vide reference cited, informed that the progress of data uploading on the AISHE portal in the State for the years 2013-14 and 2014-15 is as mentioned below.

3. The Government of India launched at Scheme, Rashtriya Ucheham levels of level The closing dates for AISHE 2013-14 and 2014-15 is 31st October, 2015 and 30th November, 2015 respectively and the AISHE is also planning to launch survey for the year 2015-16. Therefore, it is

The Government of India launched the Centrally Sponsored Scheme, Rashtriya Uchchtar Shiksha Abhiyan (RUSA) to attain higher levels of access, equity and excellence in higher education system. RUSA envisages holistic planning at the State level and funding would be on the basis of critical appraisal of State Plans for Higher Education. Availability of accurate and reliable data is prerequisite for planning and hence RUSA mandated uploading data on the AISHE portal for all the participating Institutions/ States.

- 4. In this context, the MHRD, vide ref. cited, has categorically mentioned that the funding under RUSA to States is linked to uploading of the data for AISHE by all the Institutions /States and hence the data uploading is to be completed in the State immediately on war footing basis, so as to be eligible for receipt of funding under RUSA.
- 5. In view of the above, I request you to look into the issue personally and get the data uploaded by all the Institutions functioning under your administrative control/affiliation, immediately.
- This must be completed by 15.11.2015 and compliance reported to State Project Director, RUSA under intimation to the Government.
