Payment of Registration fee, Library fee, Processing fee of Rs.3000/ (Rupees three thousand only) at the time of admission and tuition fee Special fee and Common Service fee of Rs. 11,000/ (Rupees Eleven Thousand Only) per annum in case of Faculty of Science & Computer Science. The fee to be paid in A challan in the SBI, Telangana University Campus Branch and submit the duplicate challan along with the application form.

- I. The Remittance of the Tuition fee is compulsory for all the candidates. The eligible Full Time Research Scholars may refunded only after receiving the reimbursement of tuition fee from government.
- 2. The research scholars who have crossed the age of 35 years are not eligible for reimbursement of tuition fee from government.
- 3. After getting the above certificates verified the candidates have to submit their application form along with the joining report duly endorsed by the research supervisor to the Dean, Faculty of Department of Business Management, Telangana University on or before 30-12-2022

## The provisional admission is subject to the following conditions:

- The candidates are required to obtain the consent of a Research Supervisor before submission of application for admission in to Ph.D. programme.
- 2. The candidates admitted in to Ph.D. programme are instructed to finalize the topic of research in consultation with their research supervisor after completion of the Course work and before the research design seminar
- 3. The admitted candidates have to complete Ph.D. programme with in a minimum of 3 years for full time and 4 years for part time and maximum of 4 years for full time and 5 years for part time scholars respectively.
- 4. They have to renew their admission through proper channel by paying the tuition fee every year as per the norms of the university and file a copy of receipt or challan with the office of principal, University college, Telangana University.
- 5. They should present a minimum of three (3) seminars during the programme, including one (1) on research design and the other two (2) progress of the work and before submission of thesis
- 6. They should publish at least two (2) papers on the research area concerned in reputed / UGC recognized referred journals and journal recognized by the Department before presentation of Pre submission seminar
- 7. They should submit half yearly progress report of research work from time to time through the research supervisor. Chairperson BoS and Head of the Department to the undersigned.
- 8. The candidates should undergo course work and pass Pre Ph.D. examination with in two successive attempts from date of registration
- 9. The candidates registered as part time research scholars are required to under go course by applying · leave
- 10. In all other matters the candidates are governed by the Telangana University rules and regulations of Degree of Doctor of Philosophy. Any violation of these rules and regulation by the candidates will entail the cancellation of their registration.
