Kind attention is invited to the subject cited. The Commission issued Notifications for recruitment to the post of Village Revenue Officer (VRO) (Notifn. No.13/18), various posts of Group IV Services (10/18), Junior Assistants in TSRTC (No.11/18), Bill Collector (17/18) and various posts in Bewarages Corporation (18/18). The written examinations for these posts are scheduled to be held on 16/09/2018 FN and on 07/10/2018 FN and AN respectively.
