In pursuance of the orders issued, vide GO 5th read above, and based on the representations of Disabled Welfare Associations including the National Federation of the Blind, Telangana State Branch all the Heads of Departments in Telangana were requested in this office letter 6th cited, to exempt the employees who are Persons with Disabilities, from attending to offices including essential services or permit them to work from their home during the period of lockdown. This has a reference to Section 8 of Rights of Persons with Disabilities (RPwD Act, 2016) which guarantees equal protection and safety for Persons with Disabilities in situations of risk, humanitarian emergencies, natural disasters etc.

The period of lockdown is further extended by Government up to 29th May, 2020, vide GO 4th read above and guidelines were issued for the extended period.

Government, vide Memo 1st read above, issued orders exempting the Government employees who are Persons with Disabilities, from attending to their duties in offices including essential services and permit them to work from their home during the period of lockdown in all red, orange and green zones in Telangana.
