"Any person, institution, organization violating any provision of these regulations shall be dealt under the provisions of the Epidemics Diseases Act 1897, The Disaster Management Act 2005, regulations issued vide Ref 5<sup>th</sup> cited and other relevant Acts."

Hence all the Principals are hereby informed to see that all the University/Government / Aided/ Private Colleges follow the instructions and lock down till 31.03.2020. Further the Principals are hereby informed to take necessary action and submit a compliance report duly marking a copy to the commissioner, Collegiate Education, Hyderabad. The receipt of this letter shall be acknowledged.
